## TERMS OF REFERENCE

### Objectives:

- Interrogate the new curriculum to identify points of difference between AC v 8.4 (current version) and v9.0
- Identify mathematical concepts (content) pedagogies (proficiencies, processes) and cross-curriculum priorities that could form professional learning/resources to support implementation for implementation in late 2022/2023.
- Make recommendations to the QAMT executive on these findings.

#### Time frames and commitment expectation

- Term 3, 2022.
- Meeting schedules will be negotiated within the group, with the expectation of at least 3 online meetings (via zoom).
- Each group member will complete curriculum analysis and become familiar with AC9.
- The reference group will consist of a Chair and a minute taker.
- The group can request that the QAMT executive seek additional support/consultation with external partners such as ACARA, QLD DoE and other state associations.
- Each group member will bring their unique perspective, experience and context to group discussions.
